Our sports calendar showcases your activity in the development of AGG and the promotion of our sport. Over the past period of 2023, two World Cups and two Challenge Cups were held, including also international IFAGG B-category competitions as part of these events.

This year we are testing new IFAGG competition rules for junior and women long programs. Our choreographers and coaches continue to show creative work.

This year we have also had 4 judge courses with almost 80 from more than 20 different countries.

New IFAGG Judge Committee

In order to improve the objectivity of the work of judges, IFAGG Council made a decision to create a judge committee, inviting the most experienced judges from different continents and who do not have other positions in IFAGG to work on this committee. Judge Responsible and IFAGG responsible person in the A-level competitions

IFAGG council has decided to nominate 2 responsible persons for IFAGG A-level competitions. Judge Responsible and IFAGG responsible person are nominated by IFAGG Council.

The primary responsibilities of the Judge responsible person are to act as the IFAGG representative to ensure that all Judge Rules are followed. Judge Responsible cooperates with IFAGG Responsible person. This person is nominated by IFAGG Council. Judge Responsible is a highly qualified person in judging with long head judge experiences (at least 4 years).

The primary responsibilities of the IFAGG responsible person are to act as the IFAGG representative to ensure that all Technical Rules are followed (IFAGG Competition Organizer Manual and others). IFAGG Responsible person cooperates with Judge Responsible. This person is nominated by IFAGG Council. IFAGG Responsible person is a qualified person with judging skills and with good knowledge of the IFAGG regulations and rules with long judging experience (at least 5 years).

Greetings from Technical and Ethical Committees

These both committees are working hard to create and update our existing regulations and documents. TC has also prepared new duties and responsibilities of Superior judge, responsible judge and IFAGG responsible person. These will be tested during the WC and CC III and Europeans Championships in Vantaa. After the competition this document will be analyzed and later on also finalized for use. The IFAGG Council has made a decision to review these documents and create new ones if needed.

An analyzing group of choreographers and coaches

To improve the development work of our new competition rules for junior and women long program, IFAGG President invited some choreographers, coaches and specialists in AGG programs to the working group to evaluate and analyze new competition rules for further discussion with the IFAGG Technical Committee. The main idea is to monitor how our new competition rules work, how the competitive compositions set according to them look and how the new rules are working to actively train coaches and judges.

IFAGG Judge course instructors

IFAGG Council has made decision that only IFAGG level 1 judges can hold national judge courses in their countries. If IFAGG member country does not have level 1 judges, they can invite level 1 judges from other countries. IFAGG Council together with IFAGG office is happy to help with finding the instructors for the national judge courses. You can ask help from office@ifagg.com if needed.

IFAGG Council nominates instructors for the international judge courses.

AGG recognitions
