

<b>ENTRY FEES</b>	<p>Entry fee is:</p> <ul style="list-style-type: none"> <li>• Entry fee per group, max 6 gymnasts + 2 coaches – 100€</li> <li>• Entry fee per group, 7-15 gymnasts + max 3 coaches – 130€</li> </ul> <p>Each team may include max 1 doctor and 1 other delegate.  Additional accreditation requested over 3 amount limits will be subject to a fee of 40€ per additional delegate.</p> <p><b>PAYMENT INFORMATION</b></p> <ul style="list-style-type: none"> <li>• The entry fee must be paid via bank transfer to the LOC bank account.</li> <li>• All bank details will be published later.</li> <li>• The participating delegations are responsible for covering all bank fees in connection with the bank transfers.</li> <li>• <b>The entry fees are NON-REFUNDABLE.</b></li> </ul> <p><b>Late payments:</b>  According to IFAGG rules, late registrations and payments are subject to a late fee charge of 100 € per group (paid to the LOC).</p>

Judges' proposals must be done on IFAGG website and on KSIS</p> <p>IFAGG: judges must be registered by authorized persons in IFAGG AMS. KSIS: judges' registration for LOC accreditation must be done ONLINE by IFAGG member only: <a href="https://rgform.eu/event.php?id_prop=7971">https://rgform.eu/event.php?id_prop=7971</a></p> <p>No additional registrations will be accepted after the registration deadline <b>Deadline: April 8th, 2025.</b></p> <p>All judges must have a valid IFAGG judges' license for 2025 and comply with the IFAGG Code of Ethics for judges. IFAGG nominates and confirms judges list after the deadline date. IFAGG reserves the right to invite judges. Delegations are responsible for all judges' expenses (travel, accommodation, and local transportation, etc.)</p>

<p><b>INSURANCE</b></p>	<p>The AFAGG and the IFAGG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The IFAGG Technical Regulations foresee that all participating delegations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g., cover note or photocopy of the valid policy).</p>
<p><b>MEDICAL SERVICES</b></p>	<p>The Local Organizing Committee will provide a first aid medical service, a doctor and emergency medical transportation in the competition area.</p>
<p><b>ANTIDOPING</b></p>	<p>IFAGG Code of Discipline It's a condition of participation in IFAGG's activities that gymnasts and their assistants and representatives follow the national and international doping rules. All gymnasts and their assistants and representatives are obligated to know the doping rules. <p><b>PERSONAL DATA PROTECITON</b></p>	<p>Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, <a href="http://rgform.eu">rgform.eu</a> online environment, competition's/federation's websites and on social media channels. By registering to the event, the gymnasts, coaches, judges and volunteers are giving consent to publish visual materials (photos, videos) on which they might be displayed.</p>

	<p>In case the person does not consent with the aforementioned, the LOC and federation has to be informed in writing by the start of the competition.</p> <p>Only photographers and journalists with accreditations are allowed to take pictures and film the event.</p>
<b>ACCREDITATION</b>	<p>The Delegation will be accredited upon their arrival</p> <p><b>During the accreditation Heads of Delegations are required to:</b></p> <ul style="list-style-type: none"> <li>• check and confirm the correct spelling of the names of their entire delegation;</li> <li>• manage a passport control of all gymnasts</li> <li>• provide proof of medical insurance of all delegation members</li> <li>• manage a music check control</li> <li>• submit personal data protection declaration</li> <li>• make any necessary payments</li> </ul>
<b>VISA INVITATION</b>	<p>All delegations requiring visas must complete the visa request form and send it to the LOC (form can be found on the KSIS platform). The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the delegation member, as well as the city the visa application support letter must be sent to.</p> <p><b>Deadline: March 31, 2025</b></p>
