All gymnasts and their assistants and representatives are obligated to know the doping rules. <b>PERSONAL DATA PROTECITON</b>	Personal information of registered gymnasts, coaches, judges and volunteers are used in published official competition protocols, rgform.eu online environment, competition's/federation's website and in social media channels. By registering to the event, the gymnasts, coaches, judges and volunteers are giving a consent to publish visual materials (photos, videos) on which they might be displayed. In case the person is not consent with the previous, LOC and federation hast to be informed in written form by the start of the competition. Only photographers and journalists with accreditation are allowed to take pictures and film the event. (registering via rgform.eu or onsite)
<b>ACCREDITATION</b>	The Delegation will be accredited upon their arrival <b>During the accreditation Heads of Delegations are required to:</b> <ul style="list-style-type: none"> <li>• the correct names spelling of their entire delegation;</li> <li>• make passport control of all gymnasts</li> <li>• proof of medical insurance of all delegation members</li> <li>• make music check control</li> <li>• submit personal data protection declaration</li> <li>• make any necessary payments</li> </ul>
<b>VISA INVITATION</b>	All delegations requiring Visa must complete the visa request form (found in KSIS event) and send it to LOC by <b>May 6, 2026</b> , latest. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the delegation member, as well as the city the visa application support letter must be sent to
